The Jessie Rees Foundation's current primary programs consist of sending boosts of Joy to kids and family members impacted by childhood cancer These boosts of joy include, but are not limited to, birthday JoyJars, holiday JoyJars, summertime JoyJars, NEGU PowerPacks, Family Fun Packs, sibling Blessing Boxes, and a series of Care Cards In addition, the Jessie Rees Foundation provides special custom Memory Canvases to families that have lost a child to cancer Lastly, they arrange special one-of-a-kind adventures for families to create lasting memories together For 2016, the Foundation assembled and distributed approximately 38,000 JoyJars and 10,000 other boosts of Joy that went to individual homes, 200 children's hospitals, 175 Ronald McDonalds Houses, and 118 oncology camps across the United States and other countries
