Memory Trees holds Special Consultative status with the United Nations Economic and Social Committee. The NGO's primary focus areas are No Poverty, Zero Hunger, and Health and Wellbeing. Memory Trees designs, creates and manages programs that disrupt dependencies on social benefit programs, delivering better access to resources for health. The NGO has a laser-like focus on using Sustainable Food as a foundation to create community hubs. To achieve this, Memory Trees builds urban farms and community gardens, installs fitness equipment and children's play sets, and delivers ongoing hands-on educational workshops with subjects that range from health and wellbeing, to personal finance and entrepreneurship, and more. Memory Trees also provides micro financing to create jobs in lower income communities.

Gramercy Park Community Revitalization. The Office Depot Foundation generously donated seed funding that allowed Memory Trees to start a community revitalization project in Gramercy Park, West Palm Beach. Located in a USDA-designated food desert, the 2-year project deliverables include a 6,500 sq ft urban farm built next to two basketball courts, new children's play sets, and ongoing community educational and/or personal development workshops. Local contractors were hired to install about 800 linear feet of underground irrigation, and to erect a fence around the garden. The community helped with the building of several above-ground planters. After filling these with organic planting soil our volunteers planted a selection of fresh veggies. Fruit trees were added along the inside perimeter of the fence for additional food accessibility and to provide shade in the future. This project presents a unique, holistic approach to disrupting poverty and its related symptoms, i.e. hunger, obesity, unemployment, etc. The community revitalization effort strives to deliver better access to resources for health. The project outcomes, collectively, provide opportunities for residents to learn self-sufficiency, while Memory Trees focuses on its three major objectives: No Poverty, Zero Hunger, and Health and Wellbeing. The Gramercy Park Community has an unemployment rate of about 30%, with more than 50% of residents receiving SNAP, WIC, or other social benefits. In order to assist with job creation, Memory Trees funded and created a landscaping corporation, called Gramercy Green LLC. Landscaping, as an occupation, is perfectly suited to help overcome traditional challenges related to unemployment or underemployment, because language barriers, educational qualifications, etc. are less relevant in this type of work. Memory Trees is working to inspire a healthier Gramercy Park, currently impacting about 330 people directly in this lower-income community of about 1,800 people.

Let's Get Growing. Memory Trees works with educational organizations, School Boards and other NGOs to deliver and manage after-school educational programs for Special Needs Schools, American Legion Posts, and more. Memory Trees teaches people, especially children, how to plant, nurture and eventually harvest fresh produce. To complement the dedicated focus on Sustainable Food, Memory Trees delivers educational programs to enhance STEM subject matter expertise, basic literacy, and general self-sufficiency. Let's Get Growing represents ongoing project work and a recurring revenue stream that helps to fund the organization's operational expenses. Over the past two years, Let's Get Growing successfully delivered more than 30 projects, including several community gardens at schools, special needs facilities, at-risk youth centers, American Legion Posts, Community Centers, and more. Let's Get Growing directly impacts over 10,000 children and several hundred caregivers and seniors, daily.

Boys and Girls Clubs Educational Programs. Memory Trees delivers after-school gardening programs to Boys and Girls Club students, as well as evening classes for caregivers via a health and diet program, called FRESH. The student's program teaches children to plant, harvest and nurture fresh produce. This is complemented by STEM-based educational programs, delivered in a fun, interactive manner. The outcomes of the educational program include improved literacy, basic math and science skills. Caregivers are taught how to harvest fresh produce, and how to prepare meals using fresh produce and inexpensive store-purchased ingredients. Collectively, the program offers participants better access to resources for health. A single Boys and Girls Club has between 200-500 members. Memory Trees interacts with small groups daily, with attendees in educational sessions ranging in size from 6-20 students, caregivers and others, respectively.
