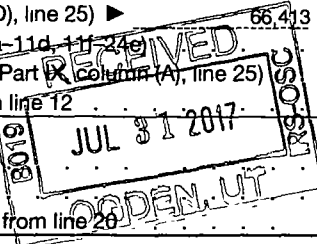

CareBOX Program provides free essential care products to cancer patients to help prevent malnutrition, infections and injuries from falls. It is estimated that up to 20% of all cancer deaths are actually due to these three areas of concern.

CareBOX Program provided 174 cancer patients with essential care supplies to improve their quality of care. Patients came from diverse ethnic and socio-economic backgrounds, many without the means to access these critical supplies without the support of this program. CareBOX Program provides nutritional supplements, infection prevention supplies, and mobility items to assist patients in their homes throughout treatment. Community volunteers pack and deliver the CareBOXes directly to the patients' homes, allowing caregivers to stay where they are needed most, by the sides of their loved ones. The items provided are used on a daily basis to improve the quality of care for the recipients. Also, from time to time, opportunities arise for CareBOX Program to provide other helpful and comforting items to cancer patients in the community. CareBOX Program uses these opportunities to expand its services on a temporary, one time basis. During 2016, this included providing over 300 costumes to patients at Dell Children's Hospital to bring a bit of fun and sunshine to them while they underwent treatment. Additionally, smaller donations of CareBAGS and nutritional products were offered at cancer clinics. Finally, a patient family was submitted for the Season of Caring program with the local newspaper. They were selected, and CareBOX Program was able to provide helpful items and services to the family during late 2016.

During 2016, CareBOX Program delivered custom CareBOXes (usually a full carload) to 174 cancer patients (with a goal of 720 patients in 2017). In addition, 290 CareBAGS containing several helpful items were distributed and 89 full cases of nutritional products were handed out to approximately 1,068 patients at local cancer centers. Finally, approximately 300 children cancer patients were provided with comfort items. All items were procured through the use of online and direct cash donations, fundraisers, distributor pricing agreements, and product drives/donations by various organizations. The mission of the organization is to provide essential supplies that are not covered by insurance to help prevent malnutrition, infections and falls. These three major risks cause up to 1 in 5 cancer patient deaths.

In mid-2016, CareBOX Program submitted one of its patient families to the Austin-American Statesman's "Season for Caring" community outreach program. This family was selected, allowing CareBOX Program to provide \$3,920 worth of items and services in late 2016 to this very deserving family of 6, helping them move forward past their very unfortunate challenges and losses. Additional donations were provided in early 2017, as well.

It is estimated that up to 20 percent of deaths of cancer patients results from these causes, and it is the program's mission to help reduce this statistic.

CareBOX Program has one central program as its mission. It curated a list of essential care supplies that cancer patients need to help prevent malnutrition, infections and falls. In 2016, CareBOX Program continued to develop relationships with Austin area cancer clinics, providing 174 patients with an often carload of critical supplies. The goal of 2017 is to provide CareBOXes to 720 patients. Patients receive custom CareBOXes full of nutritional supplements, infection prevention supplies and mobility items delivered directly to their homes via volunteers. Many patients served would have to go without these supplies if CareBOX Program did not exist.
