Transparent Fish Fund is a 501(c)(3) US non-profit organization founded in 2011 in Palo Alto, California, established exclusively for charitable purposes to connect credible Chinese and East Asian grassroots NGOs with individuals from the West. The greater mission behind this work is to foster a sustainable long-term NGO culture in East Asia, and in doing so, spread a global spirit of philanthropy. See Schedule O for more description.

Poverty Alleviation Program in East Asia. Partnered with, performed project transparency and financial transparency training. These partnerships expand our reach into five more countries. While we have already built a strong presence in China and Vietnam, we are also now helping the under-served in Myanmar, Thailand, Cambodia, Nepal, and Haiti. We have a total of 40 active projects in 9 countries. Screened over 800 cumulative NGO applicants and selected more than 30 each year to partner with while also fundraised for these NGO partners in the US. Stories were shared and updated for these NGOs which lead to the creation of the 2016 Annual Report and the 2016 Impact Reports telling donors how each of their donated dollars was spent. Staff performed field visits and due diligence reports for strategic partners. Since we started, we have performed over 125 field visits. The following was also done as of 2016 cumulatively: Financial Accountability: 275 quarterly financial reports and 750 monthly project reports submitted. Social Media Transparency: 13,000 project update blog posts from 360 NGOs. Due Diligence: Over 125 project visits by our staff. Sustainability: 60 NGOs demonstrate long-term potential, 10 have found their own additional sources of funding because of our partnership and accreditation. Graduations: 360 NGOs completed one of the three-level training programs. Strategic Partnerships: 25 NGOs have graduated from our Strategic Partnership Program. Top achievements for the past year include researched and invested into social enterprise, making it a major focus for the year. Added 3 new board members who helped us select and vet social enterprise options. Hosted first TFish 5K Walkathon, a public fundraising event. Started new partnerships with 8 different organizations. Expanded into new countries like Cambodia and Thailand. Volunteers gave back at LRS Summer Camp. Orphan computer classes expanded from Vietnam to China. Revamped our requirements for NGO partner reporting and selected winners for best reporting to grow them in capacity building.
