Our Overdose Prevention program, under the medical direction of Dr. Anne Pyllkas, has built partnerships with hospitals, first responders, treatment and sober living facilities, treatment court, and citizens to provide the lifesaving, overdose-reversal medication naloxone, expand knowledge of the limited immunity provisions of Steve's Law, and provide critical overdose prevention education. We distributed over 1600 Overdose Rescue Kits and trained over 1600 professionals and laypeople in how to reverse an opioid overdose. Many of these people were trained to become trainers themselves, thereby expanding the reach of this important life-saving knowledge. We also embedded trained trainers within many of the organizations that we partner with in order to broaden our impact. Importantly, we also worked to ensure access to evidence-based addiction treatment following an overdose. Our program is a model for states across the country and we willingly share our strategies with other states in need of guidance. We again distributed naloxone at no charge throughout the community as part of our Overdose Rescue Kits to help ensure access to naloxone for those at risk of overdose. We received the naloxone as a donation and expenses include \$218,500 as the valuation for naloxone distributed.

Our Advocacy program celebrated success on both the federal and state levels. We sponsored and supported the FEDUP! Coalition's call for federal action to end the opioid epidemic by providing leadership for the October FEDUP! Rally and March to the White House in Washington D.C. We expanded the rallies to the state level and supported 24 states in holding rallies on August 31, 2016, International Overdose Awareness Day. We provided leadership for the Coalitions successful effort to have \$1 billion for addiction treatment included in the 21st Century Cures Act. We coordinated a nationwide effort to obtain the release of the much-needed CDC (Centers for Disease Control) Guideline for Prescribing Opioids for Chronic Pain. We supported the passage of the Comprehensive Addiction and Recovery Act (CARA). CARA as signed into law July 22, 2016. We supported the introduction of an appropriation to fund naloxone distribution to laypeople in Minnesota. Our staff and volunteers developed coalitions and partnerships to increase the impact of our lobbying and advocacy. We held events, and participated in events sponsored by partner organizations, that increased public awareness of the dilemma of chronic pain and the disease of addiction. Expenses shown are exclusive of \$36,332 of donated legal and other services related to this program.

4c (Code:) (Expenses \$ 15,714 including grants of \$ 0) (Revenue \$ 0)

Our Prescriber Education program, under the medical direction of Dr. Charles Reznikoff and in partnership with the Minnesota Medical Association (MMA) and the University of Minnesota Medical School, has created free Continuing Medical Education (CME) through its lecture series on Pain, Opioids, and Addiction. Experts in these fields have presented lectures to the medical students which are then filmed, edited and posted on the website of the MMA at <http://www.mnmed.org/advocacy/Key-Issues/prescription-opioids-lecture-series> as free, enduring CME available to practicing physicians and other prescribers across the country. The lectures provide education on a variety of topics related to the responsible use of opioids and pain management ... education that is still lacking in most medical schools across the country. We have created a curriculum that is balanced, practical, evidence-based, and free of commercial bias. 13 courses are currently offered, and these are being utilized to provide much-needed guidance to medical professionals. The expenses shown are exclusive of \$4,688 of donated professional services.
