

Form 990 EZ, Part III, Primary Exempt Purpose - The organization's primary exempt purpose is to empower and support individuals with Down syndrome, their families and the community through education, information, public awareness and advocacy. DSNMC supports approximately 400+ families in Montgomery County and the metro area.

Form 990 EZ, Part III, Line 28, Program Service Accomplishments:

DSNMC has been successful in achieving its above stated mission with many initiatives undertaken throughout the year. DSNMC hosted the Techniques for Success (TFS) conference with the Frederick, MD FRIENDS group for educators, administrators, therapists and parents to learn best practices to teach students with Down syndrome and other special needs. There are approximately 400 attendees. The format allows for breakout sessions so people can listen to the topics most applicable to their child's/students' needs. This conference has received accolades from parents, Montgomery and Frederick County Public Schools and the Archdiocese of Washington Schools. DSNMC hosts social engagements for parents and families of those who have been touched by Down syndrome (winter dance, spring picnic, summer pool party, playdates, New Family breakfasts and Tools for School parent workshops). DSNMC has an active listserv so parents can connect, ask questions and share resources. DSNMC fosters advocacy by having a large group attend the Buddy Walk on Washington each year to have members meet with elected officials to discuss topics of importance to our community. We have a special group for Spanish speaking families which meets bi-monthly in addition to attending regular events. Finally we have an award winning program for our older self-advocates in conjunction with ArtStream. These are a series of public speaking and social interaction workshops where the self-advocates work with peer mentors to learn how to handle social situations and become more confident speakers.
