All donations range from \$250 to \$1,000 per cause. Thirteen of the causes were specific assistance to individuals: ten distributions to assist medical patients with their medical or other expenses, two distributions to assist children in families whose breadwinner had died, and one distribution to assist with funeral expenses after an unexpected death.
