In February of 2016, Over the Rainbow Butterfly Garden received a contract through the Arizona Department of Economic Security, Department of Developmental Disabilities to be an in home care providing agency. We provide respite, attendant, and habilitation care services to members of the AZ Department of Developmental Disabilities. All proceeds above operating costs from this agency are awarded to students with developmental disabilities each year.

In 2016 Over the Rainbow Butterfly Garden began the process of purchasing a successful thrift store that operates in the city of Flagstaff. It will take over the thrift store and begin operating it on January 1, 2017. Proceeds from the operation of the thrift store will benefit local non-profits in the city of Flagstaff as well as people with developmental disabilities. Store was purchased with the assistance of a loan from President Karl Watson and loan is listed in Schedule L.

Over the Rainbow Butterfly Garden operated a small Etsy shop that sold engraved leather bracelets. Funds received from the shop benefited students with developmental disabilities. The Etsy shop was closed in the summer of 2016 and is no longer in operation.

Over the Rainbow Butterfly Garden amended it's Articles of Incorporation twice during 2016. The first time was to include the AZ Department of Economic Securities Developmental Disabilities agency that was officially given a license by the state of AZ in February 2016. This agency provides in home care services to members with developmental disabilities. The services provided are respite, attendant, and habilitation care. All proceeds are given back to students with developmental disabilities through our annual scholarships.

The second time that we amended our articles of incorporation was to include a thrift store that we purchased in June of 2016

We did not take over operation of the thrift store until January 1, 2017. All proceeds from the operation of the thrift store are given back to students with developmental disabilities as well as other non-profit organizations that are approved in our annual grant process for funding of specific projects that they need assistance with. Copies of both of the updated articles of incorporation are included.
