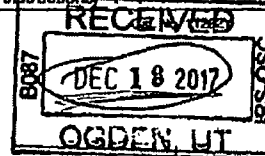

In the name of Jesus, Vision for Children is helping meet the physical, emotional, spiritual, and educational needs of children and young people, enabling them to change their world around them by breaking the cycle of darkness and poverty. Vision for Children has been called to rise up to meet this challenge, changing the future now.

Vision for Children works in the poorest section of Chile, La Pintana. In this community only 30% graduate from high school and the area is rampant with gangs, violent crime, prostitution, child abuse and child neglect. The courts routinely take children from their families due to abuse and neglect and place them in group homes called Hogars (which we would refer to as orphanages). We work through an organization we caused to be formed in Chile, Vision for Children-Chile which is formally recognized by Govt. of Chile as a non for profit. Through this we run the House of Hope which assists young ladies who age out of the Hogars at 18 or in extreme poverty to complete high school and to work towards obtaining an advanced degree. We have had young women become beauticians, practical nurses, teachers. Many of our young ladies are the first in their family to graduate high school. We also assist local schools, Hogars, and neighborhood children in English, band, choir, art, tutoring and other programs designed to keep them out of gangs and in school. We send missionary work teams and interns to Chile several times a year to help in these programs and to do construction of facilities to enhance and assist us. Some 500 children and young adults are assisted annually.

Vision for Children has been asked why we do not assist in the U.S. In 2014, a five unit apartment building in Kingston, NY was donated to Vision for Children. Engineers and contractors were consulted to bring the facility into code compliance with the city of Kingston. The city of Kingston delayed in granting a permit to make the required repairs and instead caused the buildings to be razed. This building was to become a House of Hope for local orphans and children forgotten in the Hudson Valley, NY. The location is convenient to local colleges and Boces programs. Vision for Children is currently in the process of a legal proceeding to be able operate a House of Hope in the Kingston, NY area. Some of our expenses are related to this effort, taxes, fees, travel, etc.
