Civic Engagement: We conducted a six month canvass across all seven reservations and three urban centers with significant Native American populations to help eligible voters register to vote, educate voters on the importance of civic engagement at all levels in their communities, and inform voters of the newly-authorized satellite voting stations on reservations across the state. We worked with elected officials to implement the new satellite voting stations. Our outreach program is designed to ensure that every Native American who wishes to vote and engage with elected officials can do so without unnecessary barriers.

4b (Code:) (Expenses \$ 32,420 including grants of \$) (Revenue \$)

Polling: We began a first-of-its-kind poll of Montana Native Americans to gauge community attitudes toward civic engagement, education, and economic outlook. The poll has reached out to over 2,750 citizens in ten communities. When complete, we will use the poll results to create effective strategies for leadership development, civic engagement, education and advocacy efforts across Montana.

Medicaid Expansion Outreach: The 2015 Montana legislature enacted expanded access to the medicaid program in an effort to provide access to quality healthcare to a broader section of Montana's economically disadvantaged citizens. We conducted a door-to-door canvass that reached over 10,000 citizens to identify individuals who may be newly eligible for coverage. We provided staff support for one-on-one consultation with potential enrollees and then connected them to navigators and certified application counselors for evaluation and enrollment assistance. We also hosted several free events that were open to the public to share information on the expanded Medicaid program.
