We then work with volunteers during a packing event to pack backpacks with supplies and work to distribute them to kids in-need. We provide many of these backpacks directly to families we support and then we count on other nonprofit partners to help us in distributing them to underprivileged children they have within their programing. We serve children from Kindergarten to 12th Grade with backpacks and supplies and try to tailor each grade to what is most needed based on their age.
