Tutoring, Transportation, Uniforms, and supplies for 61 indigenous Ixil Mayan children to go to junior and senior high school.The Nicolás Fund for Education provides safe transportation for students from their village to the school in a nearby town which is approximately 40 minutes away and back home again at the end of the day. In this town of Nebaj, these students not only attend a private junior high and high school but also receive tutoring, supplies and a nutritious meal.These students live in a remote agricultural region in the highlands of Guatemala where most young people do not have an opportunity to receive higher education beyond the sixth grade.

Impact Team TripsEach year NFE provides three opportunities for individuals, families, and especially educators to participate on Impact Teams to Guatemala. Two teams each year share educational enrichment activities with the junior and senior high NFE students and staff, as well primary school educational enrichment activities in two small village primary schools. TheseTeams impact team members through relationships formed with students and village members. Team members also host an annual Teacher Professional Development workshop for local teachers. The workshop allows the teachers to earn attendance certification through Seattle Pacific University. Virtual classes have included SPU classes, teachers from the United States as well as as local teachers presenting information to their colleagues. The third team of the year attends the graduation of the NFE students. During each trip the team also visits the students and their parents in their communities to build relationships, pray for and encourage the families as well as address any questions or concerns about the NFE program.

Capital ProjectsWith assistance from the Bellevue Presbyterian Legacy Fund and others, NFE built a science laboratory supplied with science equipment in accordance with Guatemalan School regulations.
