Part 1 Line 2 Great Plains Foundation has a project to translocate rhinos from the highly vulnerable regions in South Africa to Botswana. The Foundation uses donations received to acquire the rhinos, quarantine the rhinos and transport the rhinos into pre agreed release sites. Post release the project employs a team of dedicated rhino monitors who patrol the rhino in the wild ensuring their safety and security. Each translocation is treated as a mini project with the budget pre agreed upfront. Cost disbursements are managed against the agreed budget. The budget includes capital equipment, human resources and ongoing veterinary care of the animals. The project co-ordinator reports both to a steering committee of the Foundation and to the National Rhino Co-ordinator in Botswana as well as the Minister of Tourism and Wildlife.

Part 1 Line 2 Great Plains Foundation has a number of projects to improve the economic welfare of the communities which live in the same areas as wildlife. During the year the Foundation embarked on a wellness campaign for these communities. Spend on this project is managed against a preapproved budget, with the actual expenses accrued as the expenditure is committed.

Part 1 Line 2 Ride for Lions - The Foundation has a project to raise funds to expand the natural habitat of big cats and to safeguard big cats that roam wild in areas that communities occupy. As with all projects - monies are raised to cover specific project needs and once the funds have been raised the actual spend is monitored against the pre approved budget. In all instances third party suppliers are paid directly either by GPF or one of the GPF affiliates; all payments require valid authorised invoices in support. The costs are accrued on an as incurred and authorised basis. For the Rhinos Without Borders project the budget for the security and monitoring costs post release are provided in full for a three year period once the rhino is released.
