Removal Defense Initiative Our Removal Defense Initiative is one of the few in the nation It provides removal defense legal services for all low-income individuals in the Bay Area who have some form of relief available to them The program utilizes staff attorneys to screens eligible candidates, both in immigration detention and out for potential relief, bond opportunities, defenses to deportation, and then provides high-quality defense from start to finish Staff attorneys at SJC have sole responsibility to manage removal caseloads, attend immigration hearings and work directly with clients and their families Our removal defense program represented 50 clients in removal proceedings The market value for these services would run at least \$375,000 dollars (Continued on Schedule O)

Removal Defense Initiative (continued from page 2)Program income was approximately \$46,120 in revenue for representation Unaccompanied Children ProgramA subset of the Removal Defense Initiative, SJC also represents a growing number of children (under 18 years of age) in deportation proceedings SJC helps these children defend their deportation in a variety of ways Many of these children were victims of violence, sexual assault, neglect, or persecution in their countries of origin and through self-sacrifice and risk, escaped to the United States for a better future SJC represented about four of children in removal proceedings in 2013 and the program took in about \$4,200 The market value for this program is around \$30,000 Victims of Crime ProgramSJC's Victims of Crime Program assists clients who have suffered from a crime in the United States SJC assists clients from start to finish in seeking such forms of relief such as the U visa, T visa, Special Juvenile Immigrant Status, VAWA and other forms of protection for immigrants that are available The market value for the services provided in this program total at least 265,000 dollars The program actually netted \$20,000 dollars in revenue and represented 53 individual clients

Form 990, Part III, Line 4d Other Program Services Description	<p>OTHER PROGRAM SERVICES 4 Removal Appellate Program (continued from Page 2) SJs removal appellate program offers a way for aggrieved noncitizens to seek redress at appellate courts for erroneous decisions made by immigration judges This is especially useful for those who have strong cases but lost at the trial level for lack of representation SJC represented 3 clients in removal appeals before the BIA and succeeded in providing high quality representation The program netted a \$1,000 in revenue and provided around 25,000 dollars worth of services Immigrant Criminal Defense Initiative SJs Immigrant Criminal Defense Initiative provides primary criminal defense to noncitizens, particularly those that are risk at being placed in removal proceedings due to the criminal process SJC also provides criminal law services such as post conviction assistance including expungement, vacating wrongful criminal convictions, and sentence modifications A lot of the services provided to clients include legal advice given to clients who have criminal convictions in jail as well as actual crafting of immigration friendly pleas SJC attorneys also work with criminal defense attorneys to help them craft immigration-safe pleas to SJs immigration clients Much of the program costs were included in the immigrant defense program and thus this program netted a negligible amount of independent revenue</p>
