Schedule J General Explanation	<p>Pat Simmers is compensated for his services as the Executive Director of The Team Makers Club from the North Dakota State University Athletic Department, an unrelated organization. His compensation, consisting of base salary, pension, life insurance, and health benefits, is for his services to both organizations. The Athletic Department has not been able to determine the allocation of his salary between his services to The Team Makers Club versus the Athletic Department. The NDSUAD uses a national compensation survey on an annual basis to determine the reasonableness of compensation. The amount paid to Pat for services to both organizations includes \$123,948 in salary, \$15,984 in pension and \$14,140 in benefits. During 2016, Team Makers Club reimbursed the Executive Director \$2,781 as reported in Part VII for dependent care expenses that were incurred during work related overnight travel for Team Makers Club. The filing organization reported this income on a W-2.</p>
