THE COHC HAS FUNDED SEVERAL STRATEGIC INITIATIVES IN CENTRAL OREGON IN AN ATTEMPT TO FIND NEW AND UNIQUE PROGRAMS TO SAVE THE HEALTHCARE SYSTEM MONEY WHILE PROVIDING BETTER CARE TO PATIENTS. THESE INITIATIVES INCLUDE MATERNAL CHILD HEALTH, PAIN STANDARDS TASK FORCE, SOCIAL DETERMINANTS OF HEALTH, AND BEHAVIORAL HEALTH. THE INITIATIVES FUNDED BY THE COHC TAKE PLACE IN A VARIETY OF HEALTHCARE SETTINGS AND TARGET SPECIFIC VULNERABLE POPULATIONS. THESE STRATEGIC INITIATIVES ARE PILOT PROJECTS AND CONTAIN A THOROUGH EVALUATION PROCESS AT THE END OF EACH INITIATIVE.
