In addition, Seed Effect provided funding to enable Seed Effect Community Services to provide education and training through weekly and monthly training seminars. Seed Effect Community Services also shared the gospel with 100% of its clients and disciplined believers through group and individual meetings and in partnership with the local church. Finally, Seed Effect launched a new savings-led microfinance program, providing access to savings, loans, training and discipleship for 175 savings group members


