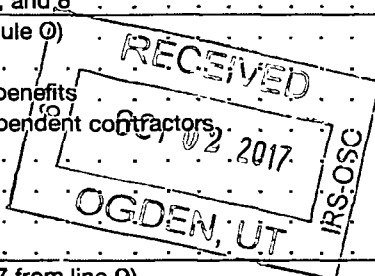

Part III, Program Service Accomplishments:

Per it Directors and Officers, East End Developers does not have any program service revenue at this time due to its ongoing efforts to secure certifications that are needed to provide low income housing; ongoing efforts to secure agreements with local governments; and ongoing efforts to convert properties to low income housing. The entirety of the contributions received on Part I, line 1 come from Organization's directors and officers to cover ongoing operational, administration costs and overhead expenses.
