But how can a teacher give lessons on computer-related subjects if he or she doesn't have access to a computer of their own? Training and courses may help provide basic knowledge, but we can only become experts through practice. It was with this in mind that, in 2007, the Ministry of Education launched the Expanding Futures project, which allows public school teachers and official institutions to obtain computers at a low-cost through an accessible financial plan. With the help of Microsoft and FunSEPA, some 57,000 teachers have obtained computers. That's 70% of all public school teachers!
