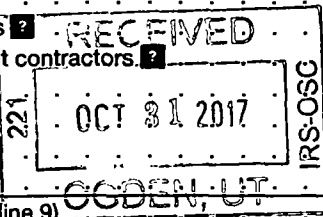

Part III Line 28 \$92,189 :Payments are for design and construction of 8.4 new miles of recreatoinal trail at Spence Mountain, a new trail system located in Klamath County, Oregon. A total of 16.65 miles (2014-2916) have been constructed with the goal of comleting a 50 mile trail system for Spence Mountain.

Benefit: Immediate - Exceeded user projetions (100 monthly) with approximately 200+ people (hikers, runners, and mountain bikers) using the trails monthly.. **Benefit - Long Term** - Upon completion there will be a new 50 mile scenic trail system for hikers, mountain bikers, walkers and runners. Usage numbers continue to increase each year. With a completed trail system plus the additional potential for snowshoeing and cross country skling activities in the winter, the Spence Mountain Trail System would be vital element of Klamath County's outdoor recreational activities

Part III, Line 29 - \$2,033 - Payment for tools/equipment for trail maintenance and new Moore Park Kiosk. The trail maintenance at various locallions was supported by 1,396 hours of volunteer work.
