



Mission is to study and discuss the relationship between conflict and international development in the hope of eliminating hunger, poverty, and violence in the developing world. The Conflict and Development Foundation supports the research, scholarship, and practice of international development - specifically international agriculture development and natural resource management. These activities are carried out through a combination of teaching, training, technology extension, and scientific research.

The Nasho II Irrigation project is a first-of-its-kind project in Africa to modernize agriculture among smallholder emerging farmers in Rwanda. The project is a collaboration with the Ministry of Agriculture and Animal Resources and is based on the agricultural development priorities of the Government of Rwanda. The project improves irrigation technology, strengthens agricultural engineering capacity, and increases agricultural productivity of farmers. It is intended as a model for agricultural technology improvement for smallholder emerging farmers in Rwanda and throughout Africa. The project will install 63 pivots over 1200 hectares of farmland in the community of Nasho along the shores of Lake Nasho in the southeast of Rwanda. Renewable power generation will also be part of this program. The pivot systems will require a source of electricity for pumping water from the lake and the operation of the pivots. The source of electricity will come from an integrated solar power generation plant.

4b (Code:) (Expenses \$ 5,552,012 including grants of \$ 74,450) (Revenue \$ 0)

Improve the facilities of the Corniche Border Crossing between Rwanda and the Democratic Republic of the Congo in an effort to promote regional trade and increase communications. This effort is intended to promote peace in the Great Lakes region of Africa. The Conflict and Development Foundation is working with regional governments to implement the program and to understand the dynamics between economic development and stability.

Funding from the Howard G. Buffett Foundation to collaborate with the Rwandan Ministry of Agriculture and the Rwandan Transport Development Agency to improve rural highway to prepare for a new agricultural teaching, research, and extension facility.

Any director, principal officer, or member of a committee with governing board delegated powers, who has a direct or indirect financial interest through business, investment, or family through: (a) An ownership or investment interest in any entity with which the corporation has a transaction or arrangement, (b) A compensation arrangement with the corporation or with any entity or individual with which the corporation has a transaction or arrangement, or (c) A potential ownership or investment interest in, or compensation arrangements with, any entity or individual with which the corporation is negotiating a transaction or arrangement. Compensation includes direct and indirect remuneration as well as gifts or favors that are not insubstantial. In connection with any actual or possible conflict of interest, an interested person must disclose the existence of the financial interest and be given the opportunity to disclose all material facts to the directors and member of committees with board delegated powers considering the proposed transaction or arrangement. After disclosure of the financial interest and all material facts, and after any discussion with the interested person, he/she shall leave the governing or committee meeting while the determination of a conflict of interest is discussed and voted upon. The remaining board or committee members shall decide if a conflict of interest exists. An interested person may make a presentation at the board or committee meeting, but after the presentation, he/she shall leave the meeting during the discussion of, and the vote on, the transaction or arrangement involving the possible conflict of interest. The chairperson of the board or committee shall, if appropriate, appoint a disinterested person or committee to investigate alternatives to the proposed transaction or arrangement. After exercising due diligence, the board or committee shall determine whether the corporation can obtain with reasonable efforts a more advantageous transaction or arrangement from a person or entity that would not give rise to a conflict of interest.

Form 990, Part VI, Section B, Line 15 - The managing fellow of the foundation was chosen in 2012 to be the executive director of the foundation. Salary and compensation were chosen based on similar responsibilities and based on past merit of the candidate when compared to related institutions. The candidate came from the Texas A&M University System and was hired at his current rate with the State of Texas. All compensation packages for the managing fellow and staff are reviewed and approved by the Board of Directors. All compensation for the managing fellow are signed by the Chair of the Board.
