Provided construction training for Haitian workers in three construction disciplines (masonry, concrete finishing and electrical). The training enables Haitian workers to obtain employment in the construction industry to provide food, shelter, school and medical care for their families. Using the apprenticeship approach of learning while earning and learning by doing, Extollo combines classroom instruction with on-the-job training and supervision. Haiti has a need for skilled construction workers at the journeyman and contractor levels. Extollo is rising up a work force of nationals to meet this need in all areas of the construction industry while developing future Haitian contractors and employers

Began the construction of the Extollo Training Center located in Bercy, Haiti. This training center was utilized to provide the training classes listed in the first program service accomplishment. This project provides employment to Haitian workers in the construction trade and many Extollo training graduates are employed. Extollo also attempts to use Haitian companies where possible for materials and supplies to further assist with the economic development of Haiti. In addition to the program expenses for the Training Center, building and land improvements totaled \$136,994 for a total investment of \$360,302

Extollo partnered with Kids Against Hunger Bay Area, another not-for-profit organization, to purchase Haitian grown rice and hold a food packing event in Haiti at the Extollo Training Center. To the best of our knowledge, this is the first time Haitians have been given the opportunity to volunteer their time to pack food for other Haitians in need after the 2016 hurricane. In everything we do, we strive to empower Haitians to eliminate extreme poverty in their country. Additional food packing events and road repairs will be completed in 2017
