The Guttmacher Institute tell us women have abortions primarily for the following reasons - - Having a baby would cause a change or interruption in their career or education - They don't have the finances to provide for a child (or another child) - They lack relational support for having a baby and/or raising a child One in three women in America will have an abortion before she turns 45 - 75% of women who have abortions live in poverty - 60% have already had at least one previous live birth - 46% are not married and not cohabiting, and feel alone in their life and decision - 64% of women who've had abortions felt pressured by others to abort. As long as organizations profit financially from a woman's decision to abort, those organizations can never provide unbiased counseling or options. Fifty-four percent of women who have abortions said they were unsure about their decision at the time, and seventy-nine percent reported not receiving counseling on other options. This is not true care for women. General Explanation - Our partnership with pregnancy resource centers. Pregnancy resource centers outnumber abortion clinics in the United States by three to one. They offer all of their resources for free and are funded by the generous donations of individuals and groups in their communities and around the country. Driven by both their concern for the women and children and their desire to see the systems overturned that make women feel abortion is their only option, people who work at pregnancy centers sacrifice time and resources to support women every day. These centers provide resources through the first three years after birth, dispelling the myth that they only care about babies being born, and not about the material resources needed to birth and raise a child. Save the Storks provides resources to pregnancy centers to gain visibility in their communities and take those resources straight to the women. One of these resources is our Stork Bus, which is a mobile medical unit that provides free ultrasounds to women outside of abortion clinics. Four out of five women who board a Stork Bus choose life after hearing the heartbeat and seeing the undeniable reality of the life growing inside them on the ultrasound screen. This is the future of caring for women in unplanned pregnancies. This is a way to tangibly provide for their needs while recognizing the complex situations that cause them to consider abortions in the first place. And this is how innovation meets genuine care to provide support and help to women in need.
