Mentoring and tutoring The Red Barn is a youth center serving middle school age and high school age children. The children generally attend the local community middle school and high school. A small percentage are home-schooled. All students are required to work on school-work for at least 45-minutes each day, while the staff is available to tutor as needed. We survey the parents/guardians to help determine outcomes. The overwhelming response was that the student grades improved by at least one letter grade while participating in The Red Barn program. There is a dedicated staff to help the children deal with various struggles and concerns. A few example: healthy living choices including illegal drug awareness, bullying concerns, sound financial decision making

Hot meal The children receive a hot meal each day. Many of the children come from disadvantaged households. The meal served at The Red Barn is often the only dinner received by the child. Many of the children are able to have free and reduced-fee lunch at school. The late afternoon hot snack (meal) is necessary due to the high percentage of low-income families in the area. The Red Barn is also a distribution center for Food Backpacks 4 Kids, sending home foodstuffs to help ensure adequate, healthy food is available each day including the weekend

The Red Barn is a youth center. There is ongoing opportunity for the children to spend time with their peers in a safe and structured environment. There is a dedicated staff to help the children deal with various struggles and concerns. There are opportunities for physical exercise. There is time to socialize in a structured and safe environment. There are special program activities such as art, music, etc. There is the occasional field trip off-premises, such as to a local baseball game
