Tacoma Community Boat Builders offers outcomes driven positive youth development programs to underserved and court-involved youth of Pierce County. Pairing each youth, one-to-one with mentors many of whom are expert craftspeople and woodworkers. Principal activities include wood shop and woodworking projects, wooden boat building and marine activities including sailing and rowing in boats built and maintained by the program participants. In 2016, program service accomplishments included the following: Serving youth in probation transformation and diversionary programs including truancy, at-risk youth, youth in need of services, diversion, and youth in foster and dependency programs. 96 3-hour sessions were offered to a total of 78 youth in 2016. More than 20 adult mentor-craftspersons contributed 3854 hours of their time, skill, and energy to working with these youth one-by-one. 49 number of youth successfully completed their initial 10 week program without 3 consecutive absences. Of the youth referred, 36% request to return or extend their referral time with us. There is an 85% non-recidivism rate on felony re-offenses for youth served during the first 2 years of running programs. Further successes for alumni include increased pro-social engagement evidenced by 13% returning as volunteers once their court cases have closed. As alumni TCBB is able to offer workplace experience internships through a partnership with Rescare Workforce Services for qualifying students, support and referral service for those wishing to return to complete secondary education, support in job search and preparedness, and/or entering into higher education or trades based programs.
