(Code ) (Expenses \$ 7,587 including grants of \$ 0 ) (Revenue \$ 7,587 ) The organization also purchases and provides to the Miami Children's Hospital cancer clinic, Kleenex and candy for the current patients The clinic is always in need of Kleenex and the candy is used to give the patients receiving cancer treatment a little treat after or during their treatment The organization also provided Comfy Cozie and Beanies to patients The Comfy Cozies are tops that have an opening that can be used to access the port easily without taking the whole top off It is easier for the patients when they are receiving chemo The beanies are for the patients who lost their hair because of the chemo In addition, "Newly diagnosed Kits" were distributed to families who recently had children that were diagnosed and these kits provided supplies that they will need in their treatments
