Run a weekly soup kitchen for the homeless in the area which presently serves 35-70 people. There is also a thrift store available to those in need. Overall there were over 100 people served through the food pantry and thrift store.

Provided classes for adults in English, Citizenship, Conversation and GED prep program. We serve 200 adult students either in the classroom setting or through one-on-one tutoring.

We have mentored about 60 youth and children with about 120 volunteers. We have chosen to provide personal attention to each child and have 2 committed and capable volunteers for each child in the program. This has proven incredibly effective, as the children have never experienced this degree of care and development.

To provide a legal clinic where individuals who cannot afford this type of service can go and get legal assistance.
