Project 1649 operates a transitional living home and provides outreach and assistance to unaccompanied homeless youth in Rock County WI. Supportive services outlined in Schedule I also are provided. Project 1649 staff work with local schools and service agencies to ensure youth's basic needs are met, and that they have access to other services/support they need to become independent adults.

Project 1649 provides assistance with meeting basic needs for more than 300 unaccompanied homeless youth in Rock County. The organization provides direct assistance to approximately 100 youth each year and more intensive case management to 40-50 youth. The Robin House transitional living home serves 14-18 female students each year. Project 1649 provides independent living/life skills training (and opportunities to practice) to transitional living residents, case management participants, and small groups within local high schools. 96% of transitional living residents and case management participants graduate, and 94% improve their self-sufficiency scores in 2 or more of 5 key categories.

The two paid staff, the Executive Director and Case Manager are responsible for screening program applicants for eligibility, determining need and then providing the needed services, as outlined above. Through continued, ongoing contact and case management the issuance and follow up use of these supportive services is tracked. Project 1649 maintains a residence home for girls and also serves the unaccompanied homeless high school youth population who do not reside in the home.
