Green Team -- In August of 2016, the Green Team took on a project to improve the North Bank Trail, which parallels the James River in what is known locally as the Richmond, Virginias own Central Park. The North Bank Trail is similarly a multi-use path where runners, cyclists, and hikers of all skill levels enjoy exercise and reflection in the James River Park System, a municipal park with about 1.3 million visitors per year. Groundwork RVA staff worked with the City of Richmond Trail Manager to identify a heavily used section of the North Bank Trail where a deteriorating board walk needed replacement. One day one of week two GWF youth measured and cut new board walk materials, including two-by-fours, four-by-sixes, and six-by-sixes. (Contd on Sch O)

Green Workforce --In June of 2016, RPS agreed to award Groundwork RVA a landscape contract that allows Green Workforce to expand into four high schools, with a combined project scope of seven RPS sites. Following this agreement, Communities in Schools committed to working with Groundwork to identify appropriate candidates for the expanded Green Workforce program, with an emphasis on youth eligible for Tier 2 and Tier 3 services those in need of additional academic and behavioral support. CIS and Groundwork work together to monitor the attendance of these participants and evaluate changes in their academic performance. In 2016, youth pursued horticulture certification through partnerships with Lewis Ginter Botanical Garden, strengthening their skills and opening career paths.
