Response: The organization was managed by all 15 employees, none of whom meet the definition of a "key employee," because none of them made more than \$150,000. All staff receive equal salaries and are expected to participate equally in the management of the organization under a staff governance structure that ensures a high level of integrity and accountability. Management includes tasks such as bookkeeping, budgeting, managing insurance, recordkeeping, coordinating hiring and training, contact management, newsletters, website management, and other administrative functions. The directors provide substantial oversight over management activities of the staff.

Response: Two staff worked closely with our bookkeeper and accountant to ensure that we have all necessary financial information to prepare the 990.
