Education: Mobile Hope continues to focus on the educational development of students who have been overlooked by either the school system or family. Our largest programs address educational development through a daily homework help program, English language classes, GED classes, and summer school opportunities. With students showing a 2-3 year academic gap between them and their peers, this is a high priority. Each week, with the help of over 60 volunteers, we see approximately 120 kids come to homework help. With strategic partnerships with local school districts and their teachers and principals, we are able to target individual student need areas, projects, and assignments. These same teachers have reported increases in assignment completion and quality of work as well as increases in comprehension and reading fluency. Additionally, to address summer slide, we offer summer school for four weeks prior to the new school year starting enabling students to start the year successfully and reduce some of the achievement gap. Lastly, our GED tutoring program is now operational with several students who have given up on public education are now receiving the help needed to succeed vocationally by meeting the graduation requirements of employers.

Expansion: The vision of Mobile Hope includes the expansion of these ideas into new mobile home communities throughout the nation. This year, we expanded to our second location in Dayton, MN where we offer many of the same services available at our flagship location, albeit on a smaller scale. This new site now has an on-site location to operate and has developed a trusting relationship with ownership of the new park. This relationship has led to a commitment to build a community center similar to the Hope Center in Corcoran where families and students would have a permanent place to receive educational assistance, resources, and positive activities. With the help of Mobile Hope, this new site also has developed a leadership team, community partners, and is developing their own board of directors to carry these ideas forward.

At Risk Youth: In 2016, Mobile Hope entered into a formal partnership with Treehouse - a 30+ year-old nonprofit that focuses on bringing living hope to hurting youth and families leading to life transformation. This nonprofit is rapidly expanding throughout the country both in locations and strategic partnerships like ours. This partnership has enabled staff and volunteers to be trained in working with at-risk youth and families. It also gives us permission to leverage the model and strategies that have worked for them in reaching these difficult teens and families. We have started offering a weekly youth program for teens called "The Journey" where students join together around a meal, receive targeted teaching through a curriculum that addresses at-risk youth, and games for social development and fun. Future elements of this program will include one-on-one mentoring as well as support groups for youth.
