THE ALGAE FOUNDATION RECOGNIZED ALGAL PRODUCTION WILL SIGNIFICANTLY REDUCE GREENHOUSE GASES, PROVIDE A SUSTAINABLE SOURCE OF BIOMASS FOR BIO-BASED PRODUCTS, FEED, FUEL AND FOODS REQUIRING A NEW LARGE SCALE OPERATIONS CREATING HIGH QUALITY JOBS FOR AN EDUCATED WORKFORCE. THROUGH ALGAL EDUCATION STUDENTS LEARN PRACTICAL APPLICATIONS OF FARMING AND BIOTECHNOLOGY TO PRODUCE A SUSTAINABLE RESOURCE FOR HUMAN CONSUMPTION WHILE DEVELOPING THE SKILLS FOR THE NEXT GENERATION OF ALGAL-BASED JOBS. THE TWO DEGREE PROGRAMS WERE SUPPORTED THROUGH THE DEVELOPMENT OF SIX ONLINE COURSES SUPPORTED BY INTENSIVE, HANDS ON, PLACE BOUND, LABORATORY EXERCISES. ATEC THROUGH ITS MANY SUBCOMMITTEES ARE DEVELOPING THE ONLINE CLASSES, LABORATORY EXERCISES, LABORATORY AND LECTURE TEXT MATERIALS. ATEC RECRUITED 18 NATIONAL LEADERS IN ALGAL EDUCATION, CULTIVATION, BIOTECHNOLOGY, COMMERCIALIZATION, AND NEW PRODUCT DEVELOPMENT WHO COLLECTIVELY HAVE MORE THAN 200 YEARS OF ALGAL-BASED EXPERIENCE. THE ATEC TEAM MEMBERS INCLUDE PROFESSIONALS FROM THE FOLLOWING ORGANIZATIONS: ALGAE FOUNDATION, ALGAE BIOMASS ORGANIZATION, CAL-CAB, UNIVERSITY OF CALIFORNIA, SAN DIEGO, NATIONAL RENEWABLE ENERGY LAB, UNIVERSITY OF TEXAS, AUSTIN, ARIZONA STATE UNIVERSITY, UNIVERSITY OF SOUTHERN MAINE, SANTA FE COMMUNITY COLLEGE, AUSTIN COMMUNITY COLLEGE, RUTGERS UNIVERSITY EXTENSION, SOLANO COMMUNITY COLLEGE, AND LYNN-BENTON COMMUNITY COLLEGE.
