The program services 10 students that are trained to create and maintain a photo booth, document corporate events through photos/videos, senior portraits and yearbook book portraits for over 183 senior and 600 underclassmen. The photography program has expanded to include sports photography and a website storefront.

The Searider Digital program provides the students the opportunity to be creative in the form of multi-media in graphic arts and design, Entrepreneurism, Business administration, Computer science, 2D&3D animation and writing. Enhanced social skills are a small subset of the educational relief that is obtained in the program. 10 college students have participated in the program since 2010 with 10 highschool intership programs in FY 1617.

4c (Code) (Expenses \$ 112,505. including grants of \$ 0.) (Revenue \$ 19,562.)

The Searider Video program provides the students the opportunity to be creative in the form of multi-media for the web and television. Entrepreneurism, Business administration, Computer science, writing, and enhanced social skills are a small subset of the educational relief that is obtained in the program. The community-at-large has rallied around the foundation through the partnering of businesses, schools, and government. 10 students have participated in the program for 2015.
