The Safe Routes to School National Partnership's mission is to advance safe walking and bicycling to and from schools, and in daily life, to improve the health and well-being of America's children and to foster the creation of livable, sustainable communities. We educate the public through research and communications, change policies and infrastructure, build capacity for leadership and advance social equity in the areas of traffic safety, promoting physical activity among children and the infrastructure of the built environment.

The National Partnership operates the Fire Up Your Feet program, which allows parents, school personnel and other individuals to access materials to help them become more physically active, track activity levels, win incentive awards for PTAs, and carry out healthy fundraisers for schools and parent-teacher associations. Thus far, more than 2400 schools have registered and there are 90,000 individual users of the program. 75% of users report that the program has helped them increase levels of physical activity.

The National Partnership's Regional Network Project focuses on building relationships, coalitions and action plans to inform, organize and capitalize on opportunities to guide policy change and leverage funding for Safe Routes to School and active transportation. The initiative operates in five selected markets around the country (Washington, DC, Pacific Northwest, Northern California, Southern California and Atlanta, GA). This project has helped create demand for Safe Routes to School initiatives and advance active transportation policies and funding streams within the targeted regions.

The National Partnership serves as the community lead for the Voices for Healthy Kids project, in partnership with the American Heart Association and the Robert Wood Johnson Foundation. Through this initiative, we engage national, state and local coalition partners and provide technical assistance to advance healthy eating and active living policies throughout the country.
