Preschools Arise Rwanda in cooperation with the community leaders in Boneza Rwanda, operate 5 preschools. The preschools serve the poorest of the poor with a Bowl of Porridge and a nurturing preschool curriculum that includes lessons in numbers and letters and English language instruction. Arise Rwanda supports 5 schools with 5 teachers and 10 assistants. Over 300 children attend the daily half day sessions. Success of the preschools is measured by the achievements of the students as they move to the government primary school. They prove to be outstanding students Kivu Hills Academy. Construction of 3 classrooms and an administrative building was completed during 2016. The team building the school includes Architect of Genesis Architecture Studio, Kigali, Project Manager Gervais Muremire, Board members Kevin Denton leading curriculum and Paul Woods leading construction. The construction of the school brought much needed work to the community and many of the local people are benefiting from the project and the income it brings to the community. Kivu Hills Academy officially opened its doors to the first 21 students on the 15th of February 2016 and was accredited by Work force Development Authority (WDA) which oversees technical education in Rwanda on the 1st of March 2016. The school currently offers one trade of construction and the students study the following subjects, Construction Technology, Construction Drawing, Construction Surveying, Domestic Electricity, Fitting and Wood Treatment, Mathematics, Plumbing, Physics, ICT, Technical English, technological French, Political Education and Religion. During 2016 the school had a staff of 5 including the principal, 3 teachers and an administrative assistant. The school offers lunch and break porridge/ tea for the students and teachers. This has helped students to study when they have something in their stomach as empty stomachs can never let students learn effectively. It should be noted that the meals served at school are the only meals that they get, so we try to make it as good as possible. This meal has helped students to follow their studies without any interruptions. Clean Water Mechanization of an existing well located on Bugarura Island in Rwanda, serving approximately 2,000 people, mostly women and children. The project shifts water wells away from lake shores to avoid the mixing of dirty water. Construction of a 13 cubic liter underground tank to harvest clean water from the surrounding natural wells. Installation of a submersive water pump at the underground tank to pump water 500 meters to the homes up the hills. Installation of a 10 cubic liter raised tank from the ground that gets water from the underground tank. Construction of tap stands 50 meters apart from the raised tank to allow locals to fetch water. Construction of a secured room to house the submersive pump, cash power and control box to make electricity facilities available. Community Development. More cows were provided to the widows in Boneza, providing milk and manure to help sustain their families and bring self respect. Women's saving/trust groups were started with over 600 local women participating. Training sessions were provided to instruct the women how to select and form a group, elect leaders, determine savings amounts, develop group rules and policies and begin to start either group or individual small businesses. Training for the local pastors were conducted by visiting clergy from the United States.
