IPSF assisted the Indianapolis Metro Police Department with the planning and implementation of the 2016 National Association of Women Law Enforcement Executives (NAWLEE) conference. This was the first time this national conference was hosted in Indianapolis and brought together over 200 female police officers and leaders from throughout the United States. At this conference, participants were educated on mentorship, advancement, best practices and other issues relating to diversity in policing.

4b (Code:) (Expenses \$ 36,796 including grants of \$) (Revenue \$)

IMPD Leadership Academy - The IMPD Leadership Academy was developed to provide additional leadership training to police officers and other first responders throughout the Central Indiana area. The program utilizes best practices, evidence-based research and innovative training models to provide first responders - typically those in a leadership role or seeking a leadership role - with tools, techniques and resources to be better leaders. It also focuses on how police, especially leadership, must continue to develop skills and opportunities to engage with the community at all levels.

4c (Code:) (Expenses \$ 26,478 including grants of \$) (Revenue \$)

Graffiti Abatement Unit (GAU) - Graffiti is a significant problem the City of Indianapolis faces. It not only increases blight in neighborhoods in need, but also serves as a means for criminal communication. IPSF developed the GAU as a solution. It operates 40 hours per week and abated over 25,000 square feet of graffiti at over 350 commercial or residential properties. All of this is done free of cost to Indianapolis residents and business owners. The GAU also partners with a local social enterprise - RecycleForce - to staff the GAU with ex-offenders who have been previously incarcerated. In addition to paying the GAU crew a wage, they have opportunities to engage with police officers for mentorship, get additional workforce development training and engage with the larger community.

Part III, Line 4d - IPSF assisted with reward and recognition, both on a formal and informal basis. This included awards banquets as well as informal methods for providing immediate feedback and recognition, like challenge coins. IPSF helped fund the IMPD Explorers, which is a group of 12 to 18 year old youth who have interest in being police officers when they are old enough. They are provided training, resources and support. IPSF provided "Barrier Buster" funds to assist with individuals re-entering society after incarceration. Funds included support for housing, transportation and food. IPSF executed the Operation Winter Ready project, which provided over 1,000 "winter ready" kits for Indianapolis homeless individuals. Kits contained blankets, gloves, hats and other personal hygiene supplies. IPSF assisted with supplies, equipment and resources for specialty units, such as the IMPD Canine (K9) Unit and IMPD SWAT team.

Part VI, Line 11b - The Finance Committee reviews and approves the Form 990, then distributes it to the board prior to filing.
