Camelback Ventures Fellows Program offers support and early stage funding to new leaders with promising ideas, and empowers them to enact change within their communities. It catalyzes social ventures led by underrepresented entrepreneurs, particularly people of color and women. We believe that genius is equally distributed, but access for social entrepreneurs is not. We lead a social venture fellowship (Camelback Fellows) that provides coaching, connections and capital to level the playing field. Since 2013, we have supported 36 social entrepreneurs.
