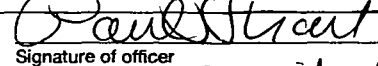

 Myanmar Elementary Student Subsidy Initiative (ESSI), and mobile medical clinics
 ESSI greatly expanded in 2016, with 70 locations in Chin and Sagaing states and more than 1900 students. The Foundation provides an adaptable English language curriculum which is taught in the community mother tongue, stipends for teachers, and bi-annual teacher training intensives in which native English speakers are brought in for week long English instructional intensives.
 Four mobile clinics were held in remote, underserved locations of Chin and Sagaing in which medical workers from Strait Clinic in Kalaymyo join medical workers from the US in health service provision.
 Myanmar was the largest field of operation for the Foundation in 2016.

 Tanzania Elementary Student Subsidy Initiative (ESSI), village clinics, and mobile medical clinics
 Operations were begun in Tanzania in 2016, and focused on launching 3 village clinics, and three mobile medical missions.
 ESSI was also launched in Tanzania in 2016, with initial operations in Mwanza, and in 14 other locations in central Tanzania.
