THE FOUNDATION PROVIDES PHILANTHROPIC SERVICES FOR INDIVIDUAL DONORS AND NONPROFIT ORGANIZATIONS IN THE JEWISH COMMUNITY. SERVICES INCLUDE GRANT MAKING, FIELD OF INTEREST RESEARCH, CONSULTATIONS WITH PROFESSIONAL ADVISORS, FUND INVESTMENT, MANAGEMENT AND REPORTING. IN ADDITION, THE FOUNDATION SHARES EDUCATIONAL INFORMATION ABOUT CHARITABLE/LEGACY PLANNING, FUNDING IDEAS AND CHARITABLE OPPORTUNITIES IN THE JEWISH AND BROADER COMMUNITY. ACCOMPLISHMENTS INCLUDE FOUNDATION DISTRIBUTED GRANTS FROM NET ASSETS TOTALING \$176,835 TO 98 CHARITABLE ORGANIZATIONS. GRANTS ADDRESSED NEEDS IN A VARIETY OF AREAS INCLUDING HEALTH, HUMAN SERVICES, EDUCATION, RELIGION, CULTURE, ENVIRONMENT AND THE ARTS. EIGHT CAMP SCHOLARSHIPS AND FOUR COLLEGE SCHOLARSHIPS AND THREE SCHOLARSHIPS FOR ORGANIZED YOUTH TRAVEL TO ISRAEL WERE AWARDED ON BEHALF OF NEW MEXICO YOUTH FOUNDATION.
