 Veteran Volunteer Force (VVF) - Brings together military, veterans and their communities. The VVF connects leaders with military and veterans to provide teambuilding and mentoring in leadership and project management. In 2016, VVF consisted of 387 volunteers supporting 1 home renovation for a veteran family, 2 building renovation projects for veteran centers, a weekend wheelchair support event distributing 120 wheelchairs, 6 food distribution events, 5 sporting events benefiting veterans, 2 conferences for veterans and their families, 3 community military civic and patriotic celebrations, 3 facility landscaping support events for an Elder Veterans Residential Home, 2 holiday events for a Veterans Home serving 305 residents and their families, one Veterans Writing Event within the LA Times Festival of Books and 3 days in all levels of support a National Veterans Stand down event supporting 900 homeless veterans.

4b (Code) (Expenses \$ 8,197 including grants of \$) (Revenue \$)
 Liberty Pass Program (LPP) - Enriching lives of military, veterans and their families through arts, entertainment, sports and recreation. In 2016, LPP supported 15 events, with 5 Books4Warriors events made up of 2 writing conferences with accomplished authors helping 100 veterans tell their stories through writing, a booth at LA Times Festival of Books bringing best selling authors alongside aspiring veteran writers to showcase skills and veterans among a 150,000 attendance, and 1,000 books to a military base library and veterans home library. Sports4Warrior supported 5 events for 50 warriors. Laughs4Warriors brought veterans' comedy to a community, sponsoring 26 active duty and wounded warrior guests. Arts4Warriors hosted an arts festival with 15 aspiring and accomplished active duty and veterans showcasing their artistic works and providing network connections

 Life Armor Alliance (LAA) - Dedicated to increase the quality of life of active duty, veterans and their families supporting the whole warrior, past and present, live stronger lives through active community partnerships. In 2016, the LAA Team supported 4 Food4Warriors food distributions of 20 tons of groceries supporting over 400 veterans (along with 430 active duty and dependents) feeding households that cared for over 1,200, provided a month of groceries for a severely paralyzed veteran and his family, and provided 25 families in need with a Thanksgiving Feast. Through the Wheelchairs4Warriors project, 120 wheelchairs were distributed to veterans in need in one weekend. In addition, the team provided a disabled veteran with a round trip air flight home to be with terminally ill father, and hosted a holiday event for 25 active duty families in need with food, gas cards, store cards, gifts and activities
