OneReef supports management programs at twelve sites in Micronesia by providing scientific, financial, and technical expertise to help local communities protect their coral reefs. We support national governments, by helping Palau and the Federated States of Micronesia (FSM) in implementing their commitment to the Micronesia Challenge, protecting 30% of the marine environment and 20% of terrestrial environment by 2020. We create sustainable, public-private financing of community conservation programs, combining national funding from Palau's tourism fees (\$4.5m collected annually) and private funding from global partners. Our formal agreements protect more than 350,000 acres of coral reef, and we provide key assistance to communities that represent an additional 150,000 acres of reef.

OneReef is replicating our model across the Asia-Pacific by building in-country expertise in Palau and FSM. We have high-capacity local staff who provide key services to our communities, including management planning, integrating traditional management practices, building community capacity to implement their management plans. We have signed several Memorandum of Understanding with Palau's Environment Ministry and Ministry of Justice, to develop a sustainable financing plan for Palau's conservation network and to build local enforcement capacity to implement marine protected areas. This national-level work will enable local programs to thrive and provide key community-based support for marine protection.

OneReefs formal Marine Conservation Agreements allow Micronesian communities conserve and protect over 350,000 acres of pristine coral reef. We have partnered with the governments of Palau and Federated States of Micronesia (FSM) to create sustainable financing and technical support for coral reef protection. In 2016, we provided 2 marine radar systems to assist enforcement rangers in identifying poaching vessels, facilitated scientific monitoring of more than 20 sites in Micronesia, and supported a regionally-significant cross-site ranger training that reached more than 30 officers.
