Currently, the organization has partnered with Synergy of Congolese Womens Associations (SAFECO) and Maman Shujaa led by visionary Peacemaker, Neema Namadamu. Together with world-wide partners, SAFECO seeks to unleash and enable the potential of young Congolese women. In the year 2016 SAFECO served 5,012 member participants, 4,271 of which were women and 741 men. It provided computer training to 175 participants and added 81 new members.
