Journeys of Compassion: Impact Nations conducted 8 , 10 to 12 day mission trips in 2016. We took teams of about 10 to 25 volunteers to Cambodia; Nepal, twice; Uganda; Philippines; Nicaragua; Tanzania; and Kenya. On these trips, the teams helped in medical clinics, distributed Sawyer water filters, provided education in health and sanitation, and taught local pastors and leaders. The teams also led in many evangelism meetings, conducted door to door evangelism , and baptized new Christian believers.

4b (Code:) (Expenses \$ **16296** including grants of \$) (Revenue \$)

Clean water initiatives: In Uganda, we built a new well and installed a water tank and pump; during our Journeys of Compassion, we distributed and set up hundreds of Sawyer water filter systems in the Philippines, Haiti, Nicaragua and Uganda. Each system will provide safe water for 20 people for 10 years, over 10,000 people total. The well and water tank in Kazinga Uganda will provide Safe water for about 5000 refugees living there.

Disaster relief was provided for Kazinga Uganda, Haiti and Nepal. Sawyer water systems and medical clinics were set up to provide safe water and health and sanitation services and education. Tarps were provided in Kazinga Uganda during rainy season.

Training and livestock, such as pigs and goats are provided for families to continue farming and raising livestock to provide income and food in Uganda, Haiti and India.

Health & Welfare Services:

During Journeys of Compassion and to assist in providing needed health and welfare benefits, we set up medical clinics to deal with chronic diseases such as digestive problems due to unsafe drinking water and lack of food. We provide meals for slum areas in India and for the orphanage in Haiti. Mosquito nets are provided to Uganda to assist with disease prevention.
