UPON COMPLETION, AN INITIAL DRAFT FORM 990 IS ELECTRONICALLY DISTRIBUTED TO THE EXECUTIVE COMMITTEE FOR INITIAL REVIEW. A REVISED DRAFT IS ELECTRONICALLY TRANSMITTED TO EACH MEMBER OF THE BOARD OF DIRECTORS FOR FURTHER REVIEW. BOARD MEMBERS ARE NOTIFIED OF THE DATE THAT A FINAL DRAFT 990 AND SUPPORTING SCHEDULES WILL BE TRANSMITTED TO THE INTERNAL REVENUE SERVICE.

THE CHAIRMAN OF THE BOARD APPOINTS A COMMITTEE TO OVERSEE THE RECRUITMENT, EVALUATION, AND COMPENSATION OF THE SENIOR STAFF.
