IN 2016, SUWANNEE PAWS INC PROVIDED SERVICES TO PRIVATE INDIVIDUALS, SHELTERS, RESCUES, AND FERAL CAT COLONIES. WE ALSO BEGAN A FELINE SHELTER DIVERSION PROGRAM, AIMED AT REDUCING THE POPULATION IN THE CITY ANIMAL CONTROL FACILITY AND PREVENTING CATS FROM ENTERING SHELTERS. WE RECEIVED A LARGE DONATION OF USED STAINLESS STEEL CAGES WHICH WILL ALLOW US TO GREATLY EXPAND HOUSING AND CAPACITY IN THE COMING YEAR. TOTAL SURGERY NUMBERS REACHED 1,433 IN NUMBER, WITH SURGERIES BEING PERFORMED ON A PART-TIME BASIS THREE DAYS A WEEK. WE STERILIZED 967 CATS AND 466 DOGS. OF THE TOTAL CATS, 269 WERE FERAL AND COMMUNITY CATS. OF THE TOTAL SURGERIES, 157 WERE SHELTER/RESCUE SPAYS AND 135 NEUTERS, OF THE TOTAL CATS, 269 WERE FERAL AND COMMUNITY CATS.
