THE GBO IS OPERATED IN PARTNERSHIP WITH GBNP AND FOUR RESEARCH UNIVERSITIES. ITS LOCATION IN THE PARK TAKES ADVANTAGE OF THE REGION'S EXCEPTIONALLY DARK SKIES. GRANT MONEY FROM THE GBHAP PAID FOR HALF THE COST OF THE RESEARCH TELESCOPE INSTALLED IN THE GBO BUILDING.
