Explanation: Modest needs has always used shared servers to save on technology cost. In December 2015, our shared server, which contained most of the data necessary to complete our Form 990 in a timely manner, suffered a catastrophic failure, after which we learned that the hosting company we had been using had not been performing regular backups as promised. As a result, we had no choice but to completely rebuild all 2015 data from hard copies and other similar physical elements documenting many thousands of contributions and disbursements. As Modest Needs has a very small staff, to complete this work for 2015, and then to manually enter the data for 2016 once the data for 2015 had been reconstructed, has taken the better part of 18 months, and it is for this reason that our 2016 filing is coming somewhat later than would normally be the case. However, we have already taken steps to ensure that our filings will be perpetually on time going forward. Most specifically, we have changed our hosting company and now use private servers with enhanced security, all of which are backed up on both hourly and daily bases, and we now also keep electronic backups of all relevant documentation on file in our office in the event of a catastrophic data loss like that we suffered through no fault of our own in December 2015. We filed our 2016 Form 990 as soon as we were confident that we could provide the IRS and the public with an entirely accurate return, and we appreciate your kindness and consideration in light of an extremely difficult situation we could not have anticipated or avoided.
