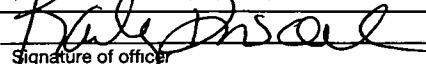
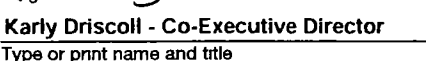

The purpose of this organization is to operate exclusively for the charitable and educational purposes as an non-profit corporation within the meaning of section 501 (c)(3) of the Internal Revenue Code 1986, as amended. The organization fulfills it's purpose by "loving others when life happens" by providing emergency hardship services to individuals within the greater Quad Cities region who have suffered hardships for reasons beyond their control to ensure such individuals have the basic necessities, including, food, clothing, housing, transportation, and medical assistance. The type of aid the organization offers in any particular case depends on the individual's needs and resources, but includes, emotional, spiritual, and practical support.

The organization's emergency services will depend on the individual's facts and circumstances. the types of services provided by the organization includes emotional, spiritual, financial and practical support. Examples of the services the organization has provided include providing assistance to allow a family to remain in their home; assistance with rent, mortgage payments, or car loans to prevent the loss of a primary home or transportation that would cause a significant hardship to families who have already suffered a hardship beyond their control; providing travel costs for family members whose relatives are undergoing medical procedures; and providing meals or groceries to families.
