What is the organization's primary exempt purpose?  
We are a charitable and educational nonprofit, dedicated to preserving, protecting and advancing the Bells' legacy and spirit of innovation. In 2016, we have successfully carried out several activities, some on-going, related to our mission. We monitored and vetted usage of the Bells' name, likeness, and materials for use with eight different companies/agencies. We educated the public about the Bells via two grant awards related to the celebration of the Bells' contributions and achievements. Through an auction purchase, we reclaimed several of the Bells' historical and cultural objects, and are in ongoing negotiations to acquire historically significant working notebooks with the Bells' notes and ideas on aviation experiments. All items that have or will be acquired will be donated for preservation purposes to historical institutions.
