


 AMURTEL works with women and children struggling to survive by providing education, medical care, options for food security such as training in improved farming techniques, and works with women to offer micro credit, self help groups, literacy training, etc. Our approach is to partner with and empower those we work with, encouraging self- initiative and self determination. We also provide immediate relief in the form of food, water, medical care, etc immediately after a disaster to all members of a community.

In Haiti, Amurtel was able to almost double the number of women receiving micro credit, started a program for over 1,000 teenage girls living in the rural areas, provided desperately needed disaster relief for victims of Hurricane Matthew by providing food, medical care and new roofs. We increased enrollment of our children's homes and added more music and art to their activities. We were also finally able to help Amurtel Haiti buy its own vehicle, providing a safe mode of travel for the children and teachers.

In Greece we saw the Amurtel Mothers and Babies program move into its own space, offering pre and post natal care to hundreds of women each month. Well baby clinics for babies under 2 years old, nutrition counseling to moms, and distribution of diapers, baby carriers, strollers, welcome kits for expectant moms, along with vitamins and nutritional supplements. 2 full time translators were hired.

In India, working toilets were added to 4 schools operating in very poor rural areas, food supplements were provided for the girls living in orphanages, and teachers were trained in working with children experiencing trauma. Medical care was provided for numerous old ladies living without family support and struggling to survive on their own.
